**CHADDS FORD TOWNSHIP** Business Privilege Tax (BPT) Registration is a flat rate of \$100.00 per tax year, per business and/or person(s) engaging in business within the Township and must be paid on or before January 30<sup>th</sup> each tax year. Person(s) starting a new business after the January 30<sup>th</sup> annual registration due date are required to register within 30 days of commencing business in the Township. A penalty of an additional \$100.00 will be imposed on annual renewals and/or new business entities that fail to register and/or pay the registration fee by the required due date. If your business is Exempt from the Business Privilege Tax, kindly complete this form, check the “Exemption” box below and attach tax documentation in support of annual gross receipt of \$15,000 or less.
